

Disinfection and Deep Cleaning Services

All private cabins & will be thoroughly cleaned before every shift which includes a disinfecting wipe down of all workstations.



We are using **Taski Virex II 256 disinfectant** for all surfaces, which is an EPA and FDA certified, healthcare grade disinfectant.

Access Protocol

- Infrared thermal scanning of individual's body temperature before entering in Quest facility
- Mask is mandatory at all time. We request to arrange your own masks
- Contactless entry and exit system
- Contactless registration for visitor management
- Wearing your ID card is recommended, if you wish to be recognized behind the mask




Access protocol

- Food and package delivery will be restricted to the security desk at the end
- A list of authorized hospitals for COVID-19 treatment will be available with the community team

Social Distancing


- Substantial distance between seating in all common areas
- Avoid public gatherings in common areas & outside office premises
- Avoid person-to-person contact including handshakes and hugs
- Use staircase and avoid elevators as much as possible
- Meeting rooms to half capacity
- Avoid cafeterias. Eat lunch at your desks
- Common amenities like gym and pool will be temporarily closed
- Follow floor markers in areas like elevators, turnstiles and pantries

Visual Signages

Following signages will be placed at designated locations across the facility:



- 6 feet distancing.
- Reminder to Sanitize.
- Cough / sneeze protocol.
- Wash your Hands.
- Sick at work policy.
- Wellness Message

Food & Beverage

- Coffee machines and water dispensers will be operational. Touch button type dispensers will be sanitized every 30 mins, whereas other machine surfaces will be sanitized every hour.
- The pantry will be available in the recommended Personal Protective Equipment (PPE) as per said guidelines.
